FROM THE INSTITUTE PRESIDENT, IAN LAVIN

We live in interesting times.

There has been much to keep adjusters with their noses to the grindstone over the last 12 months.

Across all regions of our membership base the 2010 calendar year has been one of extraordinary activity. Collectively, probably the greatest in living memory.

Cyclones in the Pacific and Queensland, cyclones, typhoons, floods, volcanic activity and tsunamis in Asia, unprecedented storm activity in Victoria and Western Australia, wide spread flooding in Australia and of course a major earthquake in Christchurch New Zealand. The latter resulting in some 200,000 reported claims alone whether under the statutory scheme or in the private sector.

The 2011 AICLA Annual Conference will again be held at the West Plaza Hotel in Wellington.
