



FROM THE INSTITUTE PRESIDENT, IAN LAVIN

Hello again. Another month has passed and although there has returned some normality to market conditions from all accounts members across New Zealand and Australia remain extremely pressed both with normal business matters and work in progress.

May is busy for your Board with a Directors' Meeting being held in Melbourne in the first week. This was followed mid month with the President's and Secretary's annual trip to New Zealand.

The Board Meeting in Melbourne welcomed recently appointed director Keith Patterson, representing Queensland.

We had a full agenda and a mandate was given to enter into discussions with ASIC over the desirability for appropriate minimum requirements for the use of the title 'Loss Adjuster' as there is much confusion in the market place. Of course we have a degree of control over 'Chartered Loss Adjuster' but that is where it stops. The Board feels that it is important for there to be differentiation as the unfavourable recent 'Press' is irksome as it tends to tarnish one and all irrespective of qualifications and level of training.

The Board was updated on the new 'base entry' qualification and we are now at a stage where we need to obtain 'buy-in' from the majors and move earnestly forward. Feedback to date regarding the concept has been encouraging.

Approval was given to proceed with a claims convention in Shanghai, in April 2012. This is a follow on from the successful claims convention we held in Kuala Lumpur 2010. There is much to be done to bring this to fruition but already we have our sights on a smorgasbord of interesting topics. I will keep you informed as the convention develops but would welcome any feedback from members with ideas for content or suitable speakers.

Concern was expressed at the meeting regarding the difficulties some members are experiencing in maintaining CPD accreditation (30 hrs each year). It is worthwhile all members review the requirements especially the availability of 'on line' education such as the papers available on our web

site which may provide an alternative pathway to those who are currently extremely 'time poor.'

On our trip to Wellington New Zealand we attended the NZ Division AGM and this included a presentation by the Earthquake Commission followed by an overview on the 2011 Australian catastrophe situation. Unfortunately, the NZ Division had to cancel their annual conference because of the sheer volume of work being experienced by members. In lieu, the Division is sponsoring all NZ based members attending CC11 NZ\$200, an amount also being matched by the Board as a 'one off' for NZ members providing total relief for NZ members of NZ\$400. The decision to do so was unanimous at the Board Meeting and reflects the fact that NZ members have missed the opportunity to stage their own conference this year because of circumstances beyond their control. We are hopeful that this will be an incentive for NZ members to gather in Sydney for CC11 on 18 & 19 August.

Whilst in NZ we also had interesting discussions with senior staff at the NZ Insurance Council and Earthquake Commission and shared valuable information regarding the catastrophes that have hit our respective markets.

Finally, in closing I wish to pay tribute to the sterling efforts of retiring Board member Grahame Smith (NZ) and welcome Leon Briggs, the new NZ Division Chairman and Board director.
