FROM THE INSTITUTE PRESIDENT, IAN LAVIN

Hello again

It is with great sadness that I commence this month's newsletter as advice has just been received of the recent passing of the extremely well known and regarded member Vin Gallagher. Vin was an expert adjuster specialising in property losses and held the role of 'National Technical Leader' with Cerno Ltd in Sydney. Vin will be sadly missed by all his colleagues and indeed the insurance industry in general.

Last month's newsletter was written 'on the road' in the midst of our annual 'Asian tour.'

Following the successful meeting in Jakarta we then travelled to Kuala Lumpur for a series of meetings including a CEO's breakfast, executives of the Malaysian Insurance Institute and culminated in a most successful meeting of members and prospective members held at the 'Bankers Club.' There the highlight was meeting and talking face to face with many members from the audience of nearly 50 over refreshments following update presentations from Tony Libke and Stephen Kwang and an overview from yours truly of the challenges being experienced from last year's Thailand floods.

Our final stop was Singapore where we hosted a CEO's breakfast, were lunched by committee members from the Singapore Insurance Institute and held a similar meeting to KL for some 40 members at the premises of the Singapore Insurance College.

Of particular note was the positive feedback from the SII regarding their successful delivery of the Claims Technicians Course where in excess of 80 attainments and enrolments have been recorded. There is some prospect that the course (which has some local modifications in terms of law components to that originally launched in Australia in 2003) may become a mandatory requirement for all claims department personnel.

Your Board met in Brisbane on 10th May and spent a very busy day with a full agenda. Much of the time was devoted to the future of our education offering. Immediate Past President Ian McWalter was invited as a guest during

discussions on the 'base entry training needs' project and provided his views and a précis of the Consultant's findings. It was determined that the report which included interviews with entry level and senior loss adjusters concluded that the Diploma of Loss Adjusting was to a very large extent meeting the needs of entry level loss adjusters. The Board also voted to maintain the Diploma course for the time being within the Australian Qualification Framework (AQF) although the conclusion of delivery arrangements is a matter now left to the executive. Further meetings are scheduled in early June.

The Board has agreed to the re-establishment of the Institute of Claims Technicians to meet demand coming from the Asian markets. The Asian Claims Convention in 2013 will be held in Bangkok in April with date and venue to be finalised. AICLA will be making a submission in respect of the review of General Insurance Code of Practice. Also it was agreed that the history of the profession in Australia, New Zealand and Asia be preserved and recorded and we will be looking at how this can be best done. Thank you to Peter Chapman in Victoria who raised this matter.

I'm also pleased to announce that a nomination was received to elevate Ian McWalter to 'Life Membership' for extraordinary services to our Institute over many years and this was unanimously carried. Congratulations Ian and I'm sure you will be welcomed with open arms into what is very obviously a highly esteemed and exclusive group. As most of you will know, Ian, apart from being the Immediate Past President has been a stalwart on the education front for well over 15 years including a period as Education Director and also served as International Development Director. Well deserved.

Another significant outcome was a change in title for Tony Libke. For some time, Tony's official title with AICLA has not been reflective of neither his duties nor responsibilities. In a unanimous vote by the Board, Tony's title has been changed with immediate effect to 'Chief Executive Officer.'

Finally, in closing, I'm pleased to advise that the programme and logistical arrangements for CC12 have been finalised. The electronic brochure for the event to be staged on 2nd and 3rd August 2012 in Sydney is now in the final stages of production and tremendous support has again been afforded by sponsors. The brochure will be with you all shortly. Thanks to all the committee and ANZIIF staff for their valuable input.Until next month...

VALE JOHN VINCENT (VIN) GALAGHER



1957 - 2012

The world of loss adjusting, and in no small way the world of insurance, lost one of its quiet but stalwart figures with the untimely death of Vin Gallagher on Saturday 19th May 2012.

Vin started his career in loss adjusting in the 1980's in Manchester, England with Cunningham Hart. In 1995 he and his wife Angela moved to Australia where Vin joined the Sydney office of Thomas Howell. He had subsequent stints at GAB Robins and Technical Assessing before moving to what is now Cerno in 2009.

He had a capacity to reach out and give back, to always extend the hand of friendship and help. Whether this was through mentoring younger adjusters or giving service to AICLA it was done with conviction and good humour. It was a conviction that looking after others and reinvesting in the industry was part of the role of a loss adjuster. In more recent years this widened to Vin having an active involvement in the charity Sailability and the War Veterans Association.

On taking up residence in Australia in 1995 Vin transferred his membership of CILA, where he was an associate, to the Australasian Division later being elevated to a Fellow of AICLA in 2000.

He served as a member of AICLA NSW Division Council for some years, his wife Angela also acting as secretary. He was also involved in the ICT exam programme and which is now bearing fruit in Asia. Vin was also an AICLA Director in 2002 and served on the AILA education committee.

The English poet John Donne remarked "the death of any man diminishes me" and the death of a person within our industry, of Vin's ilk, well loved, well respected and well known is the moreso. It is perhaps though the loss of that quiet and solid dependability, Vin's mainstay, that makes his death the more poignant and difficult to contemplate.

Vin is survived by his wife Angela.

ON-LINE CONTINUING PROFESSIONAL DEVELOPMENT (CPD)

FUSION, POWER SURGE, LIGHTNING AND BREAKDOWN

A title like this is apt to send shivers down the spine of many a general loss adjuster! If fire and flood were not enough, electrical and electronic technology have brought new risks, many of them distinctly puzzling to the non-technical person. Domestic fusion claims, while not commonly handled by loss adjusters, are straightforward enough — provided that they refer to the 'burning out' of electric motors as defined in the wording. This leaves aside the fact that 'burning out' is a highly misleading term! But when we have a claim for 'fusion' of a plasma TV or hi-fi installation the scene changes from routine to the murky depths of electronic mystery. There is no electric motor in a domestic plasma TV or hi-fi rig.

And what about power surge? Can there ever have been a more misused term, bandied about with wild abandon by unqualified people, many of whom are employed as so called 'technicians' or even 'engineers' in the retail computer and domestic equipment field? If a computer or other piece of electronic equipment fails, it seems that the cause is nearly always flagged by insurers and hopeful suppliers as 'power surge', while it is nearly always simply not the case. But there are genuine cases of power surge, such as a motor vehicle accident involving an intermix power pole...

Lightning. Now here is a straightforward peril. Or is it? Does the user have to be struck dead at the keyboard (as alleged by a loss adjuster many years ago), or can a thunderstorm in Perth damage equipment in Sydney (as alleged by a broker many years ago). And breakdown. What actually causes it? Why should equipment break down and does the normal policy ever cover it? How does it relate to fair wear and tear or inherent design or manufacturing fault?

The murkiness thickens even more deeply when we consider software problems, and malware — all those nasty infections that strange folk seem to delight in perpetrating. Our paper on these topics at CPD041 will not provide magical answers to all these questions but may partly enlighten non-specialist adjusters, even if it is only to avoid involvement!
