# WESTERN AUSTRALIA

On the 24th May we had the pleasure of Norm Cunningham a Building consultant who provided us food for thought with respect to current home construction practices and faults that can result as structures age . His presentation was titled a Loss Adjusters Dilemma and very much suggested that things should not always be taken at face value and given a thorough investigation as they were not always as they seemed. Norm provided some excellent visual examples of a few problems that he had encountered in assisting the insurance Industry over the years after earlier attempts of claims rectification had re occurred. It was a timely reminder in the current trend of just expeditiously getting matters "off the plate" with performance based pressures. This can lead to processing without a proper evaluation which could result in subsequent "Re Birth" of the problem.

# ON-LINE CONTINUING PROFESSIONAL DEVELOPMENT (CPD)

#### NATIONAL DISASTER INSURANCE REVIEW

Loss adjusters will not need reminding that recently we have been — and still are — going through a period of unprecedented disasters in our region. These have strained resources in the insurance industry generally and not least the loss adjustment fraternity. Often this has been at a personal level. It has not helped that there have been for some years developments within the industry that have tended towards reducing the breadth and effectiveness of the service base. It must be remembered that an insurance policy is a useless piece of paper until there is a claim, and that a genuine claim must be met promptly. It is also in the nature of disasters that multiple claims will arise simultaneously, and an unfortunate feature of human nature that some of them will be exaggerated or false, and thus dilute levels of service given to those really in need.

The Australian Government issued the National Disaster Insurance Review in September 2011. We reproduce here the Executive Summary, which makes interesting reading. In the final analysis adjusters are bound by their instructions, amongst which the actual policy wording is a central part. We do not have the luxury of making political judgements, and it is certainly not our role to make broad interpretations of policies — much less gratuitous comments about them either to claimants or clients. Nevertheless it is instructive to note how issues are tackled by insurers at the front line level as well as the reaction of loftier entities to the events we all suffer, together with their suggested remedies.
