FROM THE INSTITUTE PRESIDENT, LEON BRIGGS

Dear Member,

Although most of us travel in our jobs, some locally, some regionally and some farther afield; one of the great privileges of being President of AICLA is the chance to travel and meet members. April is the busiest month for AICLA as it brings together both the Asian Claims Convention and also the visit to various countries in Asia.

This year the convention was held in Bali. Whilst it had the added advantage of being a very nice and relaxing venue, it was chosen for two reasons: ease of access and the fact that we had not yet held the convention in Indonesia. Clearly the choice was well received with some 140 attendees from 15 different countries present – a record for the convention. It is one of the longer conferences on the insurance calendar, with two full days of presentations across a wide range of subjects – 14 different presentations in all. We received excellent feedback on the content and format of the convention and next year's event will likely be held in April 2019 in Phnom Phen, capital of Cambodia.

At the conference dinner it was also my pleasure to award the Charles Buchanan Prize to Nguyen Son of Vietnam and the Carey Bird Scholarship to Ms Februzi Nasution from Indonesia. Congratulations to both of them for their hard work. The question for the 2018 Cary Bird Scholarship has just been released and has been written with the intention of appealing to a wide range of members. With a prize of either attending the convention in Asia, the conference in Sydney or A\$3,000 in cash, it is a fantastic opportunity and I encourage members to consider entering.

Following the convention Tony Libke (AICLA CEO), Andrew Khoo (International Division Chairman) and I visited members in Asia. This region is the largest by membership, with almost 30% of AICLA members belonging to the international division. Having already been in Indonesia, we then visited Singapore, Malaysia, Thailand and Hong Kong; the five countries with the most members. In most locations we met with the local institute (either the local loss adjusters' institute or the local national insurance institute, or both) had lunch or dinner with members, and provided a technical presentation. In total we met over 100 current and prospective members.

We also had the good fortune to meet with the President and CEO of CILA, who were travelling through Singapore at the same time that we were. Although there are areas of overlap between our operations, most notably in Asia, we do not see ourselves as bitter rivals. Both organisations have a common goal of improving the practice of loss adjusting, both for the benefit of the community and for loss adjusters themselves. Our dialogue with them continues, including a meeting when I am in the UK in early May.

Although it was two weeks away from my regular job, it was pleasing to see the level of support for the profession of loss adjusting, and for professionalism of loss adjusters. Long may it continue!

SOUTH AUSTRALIA

The SA Division held an Educational Seminar with the topic being "Effects, concerns and issues with building movement claims" on 13 March 2018.

Gavin Park of GP Forensic Consulting Engineers spoke about the soil conditions in and around South Australia, focusing on what movement can be expected and the damage which is generally sighted, given the circumstances surrounding the claims we experience every day.

Michael Tilley of HWL Ebsworth Lawyers gave his opinion on the findings in the Victorian Supreme Court case Guastalegname, Nunzia v Australian Associated Motor Insurers Ltd [2017] VCS 420, and the impact it may have on future claims for building movement where storm and water leaks have been noted as contributing factors.

The seminar was well supported with 60 registered Loss Adjusters and Insurer's claims staff in attendance, ending the day with a quiet drink to chat about the discussions just held and network with colleagues.

Another training seminar is scheduled to be held in August/ September 2018, and we will let you know more, as details come to hand.

ON-LINE CPD

WIRELESS – A UNIVERSAL TECHNOLOGY

Time for a look at the world outside loss adjusting, although as loss adjusters we do owe much to what is now discussed.

Nearly every one of us takes for granted that we can listen to the radio, watch television, use our smartphones, have internet access without a cable, even operate garage doors remotely and use just about every convenience we enjoy today. In addition our aircraft are safely controlled, as are our ships, police, ambulance, fire appliances, taxis and even (unfortunately) the military. 'Of course,' you say...

Yet all these conveniences — indeed mostly necessities each of which is made possible by various inventions as time has passed, is ultimately due to a single invention, that of wireless. The transmission of intelligence through air or rather through space.

At this stage, most people think of Marconi, an interesting character. He was by no means impecunious and labouring away in some sparsely equipped back room. Far from that, he grew up on a large estate in Italy, where many of his wireless experiments took place, and at age 20 he had a personal butler who assisted him with these. Later experiments took place from his private yacht...

Notable too is something common to many inventors. Despite all his efforts to communicate with the government of the day, he was not taken seriously. At least not in his home land... at first! He had to travel to England in order to get a fair hearing, and many of his experiments took place from there.

But, despite popular belief, Marconi was not the inventor of wireless. That honour belongs to Heinrich Hertz, who discovered in about 1895 that sparks in one circuit could be made to cause sparks in another some (quite short) distance away, with no wire joining them. That discovery proved the theoretical forecasts of James Maxwell in 1864, when he was just 33.

What Marconi did was make wireless a practical utility particularly for ships, the rescue of many from the ill-fated Titanic being a good example of its utility. Marconi was also a businessman, developing a virtual monopoly on ship's wireless, with operators as well as apparatus owned by his company.

Of course many developments have followed, including television, in itself with a history much misunderstood. So much flows from those early inventions that we needed two papers to cover the subject, right up to what digital radio and TV actually mean.
