
# FROM THE INSTITUTE PRESIDENT, LEON BRIGGS

Dear Member,

This is my last newsletter as President and caps the end of a very successful month.

The highlight was the AICLA/ANZIIF Sydney Claims Convention, which had approximately 300 people in attendance. I particularly enjoyed being able to present Haryo Suseno, Melanie Richardson and Paul McConnell their awards for outstanding academic achievement whilst undertaking the Diploma of Loss Adjusting. It is worth acknowledging Haryo Suseno who travelled from Indonesia to attend the conference and be awarded his certificate.

We also met with delegates from the Loss Adjusters Association of Japan and signed a memorandum of co-operation. I thank the President of the LAAJ, Makoto Uchiyama, and his colleagues. We also made great progress in organising the 2020 Asian Claims Convention, which is planned to be held in Japan in April 2020.



My final thoughts to share with you come from a theme that ran through a number of the sessions at the claims convention, and that is communication. It is interesting that I have been to conferences, internal workshops and listened to the results of client surveys for more than 25 years, and a consistent message is that people often find that there are stages of a claim where they don't know what is happening or they aren't being communicated with. I'm not suggesting that I am any better than the average adjuster in this (I'm sure I'm not), but imagine if we could actually keep clients well informed.

Some of you will be good at this, others not so much – it is difficult to be good at every aspect of our job and we all excel

at some areas more than others. Imagine how much better the whole industry would be though if we could solve the communication problem. Maybe it is an unachievable utopia, but after 30 years in the industry it is an area in which I think I can put effort into improving myself.

AI and all the other fancy tech ideas will be good at communication. They will have milestones, automated messaging and pre-determined touchpoints, as well as the ability for the client to go on-line and update themselves. We can utilise some of these technologies, but ultimately there are still personal aspects of our job that, if we can do them well, will mean one less reason for someone to replace part of our job with another system. And, more importantly, we might have achieved one more happy client.

People never want to see a loss adjuster, but we all hope that, once everything is fixed, it would be nice if they were glad that we were the one they got.

I would like to finish by thanking Tony, Ash, Clare, Kenz, as well as Michael Davies, our Education Director, and all of the Board members and Division Chairs and Councillors for their support and assistance. Being President is not an endeavour that can be undertaken alone and their support has been invaluable.

#### THE LLOYD'S DEBACLE

From time to time, many of our members are engaged to assess and adjust claims by insureds that have cover with Lloyd's, and to some the first such occasion is an early minor milestone in an adjusting career, even if the business process seems slower than usual.

Lloyd's has a worldwide reputation for accepting large or unusual risks, and more importantly as a place where uberrima fides, findentia and more simply 'my word is my bond' reign; the rock solid seat of insurance, whose reputation was typified by the reaction to the San Francisco earthquake and fires of 1906, when underwriter Cuthbert Heath instructed his agent to 'Pay all our policyholders in full, irrespective of the terms of their policies'. (Apparently regardless of proximate cause issues, a bonus not likely to have been repeated!)

The way that Lloyd's originally worked was that a small number of people of vast wealth pledged their entire assets (the expression was 'down to their last shirt button') and accepted risks, in return of course for premiums. They were the 'Names' of Lloyd's. Because the pledge did not involve the actual depositing of more than a token amount, funds could be invested elsewhere at the same time, thus enabling the Names to profit twice from their investments. The wealth of those early Names was such that however large the call on funds was it rarely made even a dent in their fortunes.

However, in the 1980s the scene changed dramatically. Much larger losses occurred, with disasters such as the Piper Alpha oil/gas rig fire a notable example. Also, the classic long tail claim was emerging in the form of asbestos liability risks, with huge damages being awarded by North American juries. At the same time, a class of 'investor' whose wealth was anything other than vast was being admitted to Lloyds as a Name.

To many of those that 'last shirt button' quickly became almost literal. Many were bankrupted and lost their homes. Some committed suicide. Many simply refused to pay, alleging that they were deliberately recruited when the existing Names realised that huge losses were inevitable. As far as is known no actual claims were left unpaid but the trail of destruction internally was such that complete failure of the market seemed possible.

But Lloyd's is still very much there and still has its good name in the eyes of outsiders, so clearly the problems were overcome. But at a cost! Many went through considerable pain and the bruises are still there. Read at CPD112 the whole story of how one of the major foundations of our industry arguably came close to destruction.
