Dear Member,


We come to the end of another year and find ourselves reflecting on the last 12 months.

I wish everyone a happy, safe and relaxing festive season with family and friends. I look forward to meeting many of you in 2019.





#### **ON-LINE CPD**

#### A MYSTERY STILL NOT SOLVED

It seems that there's no shortage of extremely newsworthy events that rapidly punctuate the trivial fare that the media throw at us daily. One of these has been a real mystery which piques our professional curiosity. Such is the story of MH370.

It seems amazing that in this modern world, when I can find on my smartphone not only the registration number, location, origin, destination, height, speed and even a photograph of the airliner I have just seen pass overhead, and with a few swipes and gestures can then see that now (UK night) the skies over the UK are clear apart from some medical helicopters, yet a Boeing 777 aircraft can completely disappear. This happened in 2014 and there is no doubt that huge sums of money, other resources and much human effort have since been expended in attempting to find the exact reason for the loss. Quite apart from providing some little comfort to the relatives of passengers and crew, the investigation has the essential aim of finding the cause of the disaster. Naturally it is of great interest to insurers to identify safety issues that may convert the possibility of loss from a mere statistic to a certainty.

However, at the time of writing we are no nearer to the solution of the mystery. Theories have not dwelt on the possibility of mechanical breakdown but have oscillated between a terrorist hijacking (no credible claim has been made) or the suicide of a member or members of the crew (early theories canvassed the unusual flight simulator

activities of the captain at home, and recently have addressed his alleged hostility to the Malaysian Government).

Contrary to the instinctive belief that aircraft are tracked by simple ground radar, the detailed information about civil air movements mentioned near the start of this article is provided by instruments transmitting from the aircraft themselves, and it turns out that this particular instrument can be (and was) switched off by flight crew (or intruders) — albeit with some difficulty as this requires much more than the operation of a simple switch — or else had simply failed.

Under these circumstances, it is to be expected that an aircraft would become 'invisible' except for the activities of military primary ground radars. However, there was still an engine-monitoring device transmitting from the plane, apparently unknown to the flight crew or others. Hence the approximation of the crash location. Just recently this supposed location is said to be wide of the mark and a new one has been suggested, so even in the time between writing this and it being read, maybe we shall have some answers at last... The story as it was known in February 2017 is at CPD094.
