## FROM THE INSTITUTE PRESIDENT, JAYE KUMAR

Dear Member,

Having recently attended the Asian Claims Convention in Phnom Penh, Cambodia, I am pleased to report that this has been a very successful event, with a record number of 142 attendees. ACC is unique, in that, it draws a wide range of claims industry professionals including loss adjusters, insurers, re-insurers, brokers, lawyers, consultants and suppliers from a large number of geographic locations. In Cambodia, delegates attended from 12 countries, and were able to share their experiences and insights of how insurance in general and claims in particular are managed in their countries.

The ACC19 presentations over two days were of the highest standard, and the venue, Sofitel Phnom Penh, was outstanding. The convention included a cocktail function and gala dinner which featured musicians and cultural performers. Feedback from attendees was positive and very encouraging. Congratulations to members who attended the convention, I'm sure it was both a valuable learning experience and memorable event. I would encourage members to consider attendance at ACC20, which will be held in Kyoto, Japan on 14-16 April. I know our colleagues at the Loss Adjusters Association of Japan will ensure an event not to be missed.

I am currently travelling with our CEO, Tony Libke, and International Division Chair, Andrew Khoo, and meeting with members and others in Bangkok, Kuala Lumpur, Hong Kong, Jakarta and Singapore. More information regarding these meetings will be in the LA News May issue.

In early May the AICLA Board meets in Melbourne, and a number of major issues will be discussed including the transition of the current Diploma of Loss Adjusting course material to skills-based units, more equitable subscription arrangements for members in Asia, and representation to ASIC surrounding the regulatory framework for loss adjusters in Australia. Feedback from members to the submission by AICLA to Treasury regarding the licensing

arrangements has been positive, and AICLA will continue to advocate to the regulator, Australian Securities and Investments Commission, for appropriate standards for those providing claims advice.

Please mark your diaries for CC19, which will be held at the Four Seasons Sydney on 24 September 2019. This is the major claims event in Australasia, with up to 300 attendees. The CC19 program is developing and the theme will be "Disasters, Disruption & Regulation", all of which are very relevant in today's environment.

I commend the AICLA website as a valuable resource for members and others interested in AICLA. The Events page is a great way to keep abreast of activities across all divisions of the institute. #### CAREY BIRD SCHOLARSHIP



#### **ON-LINE CPD**

#### FIRE PRECAUTIONS, DETECTION AND EXTINGUISHMENT

Leaving aside widespread catastrophe losses caused by violent weather events (discussed in our paper at CPD117 on Climate Change), another of the major types of loss that our members deal with is of course that caused by fire, whether it be a domestic home or a major factory complex. Such events are often total losses.

Climate change risk and loss can only be minimised by a combination of long-term measures and immediate first aid action as well as better selection of risk in the first place (not only by insurers but by insureds — such as when a site for a home or business is selected). A great deal more in the way of risk and loss minimisation can be achieved when it comes to fire.

Perhaps the most striking and at the same time obvious aspect to unwanted fire is that it is nearly always very small in extent when it starts and it follows naturally that this is the time to detect it and quell it! But even before that, attention to the construction of buildings and the materials used in them, as well as the materials stored in them is a major factor. Building construction codes in use in most countries address this, though with varying degrees of success. For example, it remains a mystery why all this time after the tragic Grenfell fire in the UK (See CPD105) the same cladding material is still in use!

Then there is the question of fire detection. Again ordinances in various countries dictate the precautions that should be taken in relation to

various special risks, including commercial premises where hazardous materials are used or stored, buildings with a number of temporarily or permanently handicapped people present, such as hospitals, nursing homes and the like.

Such precautions are very often associated with extinguishment systems, as typified by factory sprinkler installations triggered by local hot spots, or alarms triggered by such devices as very early warning smoke detectors.

Especially in winter, a number of domestic total losses occur every year, many involving fatalities. Often they are due to the human element — always the hardest thing to control. The well-known and lifesaving ceiling—mounted smoke detector can be very effective... but only if the battery is renewed correctly (there have been cases when this was removed completely to avoid false alarms from eg cooking or smoking!). Equally, smoking in bed is likely to quickly cause combustion and render the occupant badly affected by smoke before such an alarm is signalled — when it may be too late.
