# FROM THE INSTITUTE PRESIDENT, GLYN LLOYD

#### Dear Member,

Welcome to this edition of LA News, we are well into 2022 and already the Asia-Pacific region has seen significant catastrophic events causing widespread damage to both domestic and commercial properties. Damage to agricultural areas and the loss of livestock cannot be understated, as the meteorologistpredicted La Nina cycle is in full swing.

It is interesting to note that the ICA reports in their 2021 Insurance Catastrophe Summary that \$2.78b worth of claims were incurred across Australia from 6 catastrophe events, and over 212,000 reported claims. So far for the first quarter of 2022, estimates from the devastating floods from southeast Queensland and northern New South Wales, together with the excessive rainfall causing widespread flooding across other areas of New South Wales, the estimate for claims incurred is already expected to surpass \$2b and potentially go even higher than the total catastrophe events in 2021.

As a result of these significant weather events, seminars arranged in Queensland and South Australia were unfortunately postponed due to staff engagement with flood/storm claims. The entire loss adjusting industry is currently fully utilised and working in excess of 100% of their normal capacity.

It was pleasing to note that the WA Division was able to hold a successful breakfast seminar. Guy Tomlinson from National Forensic Investigation Consulting presented on the topic Fire Investigation from an Electrical Perspective. Well done to our WA colleagues for holding the first seminar of the year in Australia.

A board meeting is scheduled for 12 May, taking place in Brisbane, with an EGM taking place on the same day for members to consider changes to the Constitution. Further details of the proposed changes will be forwarded to members in the near future. The changes have been developed following detailed consultation with DLA Piper lawyers and the Board. We are also finalising a review of disciplinary procedures again after consultation with DLA Piper to bring AICLA in line with legislation and current practises.

Despite 2021 being a very busy and difficult year for a number of reasons, Covid-19 included, there was a record level of 620 enrolments in the Diploma of Loss Adjusting delivered by ANZIIF. This record was driven in part by the desire for members to complete their qualifications under the FNS15 training package before the transition to the skills-units based FNS20 education regime.

AICLA continues to work with ANZIIF to finalise all elective skills units for the Diploma of Loss Adjusting, and our thanks go to AICLA Subject Matter Experts who are taking part in this program and working with ANZIIF design experts to ensure that the new education program fits within the Australian Qualifications Framework and continues to represent the benchmark course for those entering the profession of loss adjusting.

I would like to acknowledge the hard work of Divisions, who are preparing a program of face-to-face events for 2022. AICLA is committed to providing Continuing Professional Development via seminars and workshops so that adjusters remain a valued, well-trained and important part of the insurance industry. It is imperative that we continue to be at the forefront of insurers' minds as qualified professional service providers. Details of events can be found on our website.

A special save the date for the 2022 AICLA/ANZIIF Claims Convention, a flagship AICLA event, which will again be held at the Four Seasons Hotel Sydney on 29 September. My thanks to the organising committee for their continued support, ideas, and passion to ensure that CC22 will be a huge success. ## **CLAIMS CONVENTION 2022**

#### 29 SEPTEMBER 2022 FOUR SEASONS HOTEL SYDNEY

## **NEW SOUTH WALES**

On the 28th of February, the ICA declared the NSW floods an Insurance Catastrophe. For the first time in two years, international adjusters have begun to arrive in NSW to assist in this event. Many of these internationals are now on the ground in Sydney Lismore and Ballina. As of the 24th of March, In NSW alone over 72,000 claims were lodged as a result of this event.

#### Breakdown:

- Property: 55,700
- Motor: 12,958
- Commercial: 3,366

An early estimate for repairs has been calculated at \$1,080,360,000.

## ONLINE CONTINUING PROFESSIONAL DEVELOPMENT

In this month's on-line CPD paper, we discuss revolution. You can immediately put aside the images that are no doubt forming in your mind, because fortunately we do not discuss severe social upheaval or worse. Hopefully that is a welcome change from the current broadcast news — much of it repeated ad infinitum, or from posts on social media, complete with commentaries from experts (and some not...).

This month's paper is one of those designed to take us back from time to time from our busy front line — just as necessary as is concentrated application when tackling an adjustment assignment. In our paper, we take a much calmer and broader view of 'revolution' than the word first suggests, and consider what has been the most life-changing invention or development in humankind's entire history.

Entire history? A wide scope indeed... In 2015, Dr Elizabeth Howell of Canada summarised

While our ancestors have been around for about six million years, the modern form of humans only evolved about 200,000 years ago. Civilization as we know it is only about 6,000 years old...

To most, the third number is probably readily manageable, the second capable of absorption but the first somewhat beyond the boundaries of our imagination. With such a wide timespan and so many choices for 'the most revolutionary development of all time' there is plenty of scope for differing opinions for the candidate. Many such opinions would no doubt start with 'Obviously...'

You might say that the most far-reaching development or discovery of all time has obviously been fire... or cooking, tools, clothing, speech, language, alchemy, medicine...The list goes on. For those with a more modern view, perhaps obviously the winner must be motor vehicles, flight, machine tools, broadcasting, telegraphy, the telephone, radio, television, the internet, browsers, email, smartphones, space travel, satellites, drones...

In arriving at a single suggestion one approach is to consider which discoveries or developments depend upon others and so discount those as literally non-starters. In our paper we have made this idea a partial cornerstone of our reasoning, which is nonetheless personal, as will be the reaction of each of you to it.

So what's your opinion? No spoiler! You can read about one approach — with what we hope will be some useful background information — at CPD155. If it generates dissent (undoubtedly it will) nevertheless that will be all the more useful a thinking exercise...
