FROM THE INSTITUTE PRESIDENT, GLYN LLOYD

Dear Member,

It is a busy time for AICLA, with the Education and Directors' meetings being held next month. It is pleasing to note that the majority of Directors will be attending in person, with the remainder participating electronically. The past two years have limited our ability to travel on a regular basis and I am sure Directors are looking forward to face-to-face engagement at the Brisbane meeting.

The Directors' meeting, taking place in Brisbane on 12 May, coincides with an Extraordinary General Meeting (EGM) to consider changes to the Constitution that have been recommended due to legislative changes and evolving business practises brought about by the global pandemic, such as meetings being conducted virtually. The Notice of Meeting and information memorandum covering the proposed Constitution changes have been distributed to members. I request that members who are unable to attend or participate in this EGM forward a proxy in favour of adopting the proposed changes, which have been unanimously recommended by the Board.

A significant portion of the Directors' meeting will be taken up on policy review – not only the Constitution, revised disciplinary procedures and whistleblowing policy, which have been developed in consultation with DLA Piper, but also a range of other institute policies. The review of policies has been comprehensive and provided an opportunity for continuous improvement to ensure that we are working in line with legislation and best practice guidelines. Tony Libke, CEO, has been heavily involved in reviewing policies and liaison with DLA Piper, and my personal thanks go to Tony for his continued support to ensure AICLA remains contemporary in these important areas.

The weather activity in eastern Australia has caused mass devastation in parts of Queensland and New South Wales, with record levels of claims keeping loss adjusters fully engaged. This catastrophe is predicted to be one of the largest in recent times, and whilst loss adjusters are putting their best foot forward to proactively assist in these claims, a significant issue that is now being faced surrounds the supply chain of builders, restorers and

No doubt, one of the significant topics will focus on the catastrophe events in eastern Australia during this year.

Other recent and upcoming events include a breakfast seminar held by the Queensland Division on 28 April on the topic *New Regulations in the Claims Industry and How They Apply to Loss Adjusters*. There were 65 attendees, who were captivated by the brilliant presentation from Sophie Devitt of DLA Piper covering this ever-evolving landscape. A networking event has been planned by the QLD Division for 11 May at Valley Hops, with over 200 registrations from members, colleagues and others in the claims profession. Also in attendance at the function will be Directors visiting from various Divisions, providing a wonderful opportunity for members and others to meet with Directors of AICLA.

The NSW Division is holding a Meet & Greet for members and guests at P.J. O'Brien's in Sydney on 5 May, with ticket sales exceeding expectations. This is the first such event to take place in NSW for a considerable time and we encourage all members who have not registered to join in this social and networking event.

The Victorian Division held the annual Claims & Canapes event at Melbourne Park in conjunction with the Formula 1 Grand Prix, with almost 100 attendees. The Division is busy working on a full program of events for 2022 now that the restrictions that have hampered Victoria due to the global pandemic have been removed. We look forward to supporting them in their upcoming endeavours.

This will provide assistance for AICLA head office moving into the future, with information being available at the touch of a button rather than sifting through paper files. ONLINE CONTINUING PROFESSIONAL DEVELOPMENT

Apart from overseas events, in the past weeks the daily news has been dominated by the disastrous floods along the East Coast of Australia. In some places — notably Lismore, NSW - repetitive 'freak' events have been suffered, with both residents and business owners wearily turning out ruined goods to the cluttered roadside and trying to mop up, only to be inundated again. Devastating to say the least, even for normally resilient country folk. There is much talk of 'one in a hundred (five hundred, a thousand...) year' events, labels which are now meaningless, having always been at least misleading. The obvious truth is that these severe rainstorms and subsequent floods and landslips are not freak at all they are becoming normal, as they are all around the globe. Aside from a few deniers (this writer is not aware of any in our industry) climatologists and other experts are saying that the obvious cause is climate change, and that we are reaping what in effect we have failed to sow by not planning to reduce carbon emission.

Meanwhile, the insurance industry is groaning, both literally at the pressure and bottom line of claims drawdown and metaphorically at the outcry that more should be done for less. The media is playing its usual part, sometimes thoughtfully, although a generally respected TV show host spoke of 'fine print' and advised flood sufferers to '...inform your insurance company and wait. Don't try to clean up yourself'. There are reports that some are claiming even when flood cover is not selected or is not available at all, and are shrilly vocal when there can be no insurance response. Other TV interviewees are asking the camera 'Why is flood

insurance so expensive', when right behind them is the obvious answer...

These events have placed a huge burden on the industry. At least one major insurer is desperately recruiting people to work in their emergency flood response team, among other things to liaise with assessors. But the necessarily short training course may not fully equip such people to carry out the perfect work that the traumatised public will demand, although in the face of the overwhelming volume of claims many insurers will have judged that any delay in handling them would be a worse outcome.

For those of our members that are engaged in claims involving the floods, as we know even more than the usual degree of empathy will be needed, while attending to other less popular necessities like being alert for undue claims leakage, or unfortunately even outright fraud — the latter usually but not always being condemned by genuine sufferers. In such times, the insurance industry is often labelled with adjectives perhaps better aimed at the visiting politicians whose lack of action in the past arguably contributed both to this problem and the chance of future disasters of the kind being lessened.

See CPD117 published in February 2019, where we address the issue in some detail. Of course, now three years later than that paper, the problem will have only worsened!
