FROM THE INSTITUTE PRESIDENT, GLYN LLOYD

Dear Member,



ONLINE CPD

'This coat looks attractive. I think we'll stock five of them. I like orange and I'm sure the customers will too'. Such might be the method of buying and maintaining of stock once applied by the small town or village clothing shopkeeper. The customer would buy what was available and much was determined by the retailer's taste. Or it may have been just slightly more scientific, based on the shopkeeper's observation of newspaper advertising (no TV then). On the other hand, the grocer or other retailer of foodstuffs was forced to use a more formal method, ordering and maintaining stock based on customer demand and the need to minimise wastage of perishable goods — particularly if cooling was via bulk ice instead of refrigeration. The essential element of First in First out — FIFO — was then as crude as remembering to place the new stock behind the old.

Of course, the science of inventory management has now much evolved into a major part of the running of all kinds of business, with such matters as capital tied up now taken into consideration as well as insurance. The Just in Time — JIT — principle is often experimented with but severely inclement weather such as recently seen has brought supply chain problems into focus as roads often became impassable.

The element of stock is both a major consideration in the running of manufacturing, wholesale and retail businesses, and in the assessment process following a claim. For example it is given special treatment in a Consequential Loss (business Interruption) claim.

In CPD165 we discuss the handling of the stock part of a property claim. We start by briefly looking at the various methods of stock control from a business owner's point of view, evolving from those early methods to a fully-fledged science, much of it fully computerised or even automated. In passing we list the ATO requirements for carrying out the regular stocktake,

Then we consider the role of stock in the assessment of the claim, ranging from theft or total loss by fire, where the value has to be assessed of something no longer visible or measurable, to water damage where the amount may be much more easily measured. However in the latter case, where flood exclusion applies was it flood — as now defined — or inundation from above? And can any be salvaged?

For stock now missing or totally destroyed by say fire, how do we measure the extent of the loss? How far do we rely on the last stocktake coupled with sale and purchase records. And as ever, what does the policy wording and schedule say? In the applicable policy, how is stock defined and are there any limits, exclusions or extensions?

Like most things in life, nothing is as simple as it may first appear, and surely the new adjuster who says 'Stock? Piece of cake!' is due for a fall, even if the claim is for a baker...

As at the end of March 2023, there are one hundred and sixty-seven on-line CPD papers on our facility, which has been running for some years now, and they range from purely instructional, through technical, many designed to widen the adjuster's horizon, to regular forays into FOS/AFCA Determinations to show how claim adjustments sometimes end up as official disputes and how these are resolved.
