FROM THE INSTITUTE PRESIDENT, GLYN LLOYD

Dear Member,

ACC23, being held at the JW Marriott Hotel in Bangkok, is almost upon us, and we are delighted to have received a record number of 180 registrations. This is a fantastic effort for the ever-popular Asian Claims Convention since the postponement of our 2020 convention in Kyoto, Japan due to Covid. The organising committee has assembled an incredible program with speakers from the UK, Australia and throughout Asia. The event is sure to be one of the highlights of the year for AICLA, and I look forward to welcoming one and all to ACC23 between 10-12 May 2023.

Following the Asian Claims Convention, the President and CEO will be undertaking a series of meetings with members, training institutes and Regulators in Bangkok, Kuala Lumpur, Ho Chi Minh City, Hong Kong, Singapore and Jakarta. It is hoped that as many members as possible will attend these meetings, which will coincide with my last year as President of AICLA.

Our valued education partner ANZIIF is in the process of introducing a claims course aimed at insurance claims officers and others involved in the insurance claims industry. This course will fill a gap in the market following new regulations in Australia in response to recommendations from the Hayne Royal Commission. There has been great support for the training program from many insurers, endorsed by AICLA, which will ensure that insurance claims officers are trained and educated to standards compliant with the new regulations in claims handling and settlement.

On the 19th and 20th of April the Education Committee and Board held meetings in Adelaide, South Australia. The Education Committee meeting, held with our education partner ANZIIF, was productive, and discussions are taking place to extend the Diploma Delivery Agreement for a further seven years. As always, it was a pleasure to catch up with fellow Directors at the Board meeting, with attendance in person or via Teams.

The Board meeting produced robust discussions on a wide range of topics to ensure the continued success and growth of

the Institute. I am pleased that for the fourth year member subscription rates for 2023/24 remain unchanged. LA News continues to be popular with members, with the latest statistical information showing a high level of readership and excellent feedback about the content. The Board has expanded the role of the Education Committee to be responsible for liaising with overseas loss adjusting associations in recommending standards for loss adjusting education and training in Asia. A series of meetings are due to take place in order to see how we can work with and assist other loss adjusting associations to promote and advance the loss adjusting profession. In other education news, the skills units for the Diploma of Loss Adjusting will be

finalised by August 2023, with only two units remaining to be completed. There will also be an additional section in the Theft, Money & Fidelity Loss Adjustment skills unit, with cyber being added to the learning material.

Congratulations to the winner of the Diploma of Loss Adjusting Prize and the Syd McDonald Young Adjuster Prize, Claire Lees of McLarens Brisbane. The hard work and dedication shown by Claire as an adjuster, and completing the Diploma during 2022 and achieving the highest mark, makes her a very worthy recipient of these awards.

Membership of AICLA is now at record levels. As of March 2023, reported to the Board, we have 1,072 members, which continues the growth of the Institute over the past three years. Female membership is also on the increase at 16%, and we are aware that the number of females undertaking the Diploma of Loss Adjusting skills units is at 46%, which indicates that there will be an increase in female membership over the coming years.

This year, accompanying the Institute diaries to members in December, the Board agreed to provide a high quality notepad with similar branding to the AICLA diary. These will be issued free of charge and provide instant recognition of AICLA membership.

Arrangements for CC23 are well advanced, with the event to be held at the Sofitel Wentworth Sydney on 28 September. The committee has largely finalised the program and registration details will be available in the near future. Last year a record number of delegates and sponsors attended the event, and early indications point to another highly successful convention.




