Dear Member,

It is with great sadness I report the passing of Martyn Norrie, a well-known and highly respected loss adjuster and retired AICLA member. Martyn was CEO of GAB Robins and Cunningham Lindsey in New Zealand for a long period of time. Our deepest condolences to his family.

As we finish June it is an opportunity to reflect on the past six months and look at what lays ahead for the remainder of 2023. This year in Australia the severe weather events have not hit the usual heights providing a respite for adjusters. vale *Martyn Norrie*

We are saddened to report the passing of Martyn Norrie, a doyen of the loss adjusting profession in New Zealand. Martyn passed away in Rotorua on 30 May 2023 following a period of illness.

Martyn was a founding partner in MBS Loss Adjusters New Zealand in the mid-1980s, and went on to be CEO of GAB Robins and then Cunningham Lindsey for 16 years. He led Cunningham Lindsey's Christchurch earthquake response for several years before retiring from the company in early 2013. He then managed a scheme on behalf of a consortium of insurers, resolving numerous complex multitenancy domestic claims in Christchurch.

Martyn's contribution to loss adjusting and the wider insurance industry was acknowledged with a Lifetime Achievement Award in 2013.

Throughout his life Martyn was committed to various non-profit organisations, and in 2019 he received a Queen's Service Medal (QSM) in recognition of his service to the community.

Martyn was a natural leader and a truly inspiring mentor who will be missed by the many people he guided and encouraged.


