Dear Members,



As we look ahead, the 2024 AICLA/ANZIIF Claims

This year will be the 17th Claims Convention, a well-established and successful collaboration between AICLA and ANZIIF. Themed "Claims Under the Microscope – Driving Better Outcomes," this event is the premier insurance claims gathering in Australasia, attracting delegates, industry experts, and world-class speakers. The convention will offer crucial insights into key industry issues, such as AI in claims settlement, the impacts of climate change, and the effects of arson on insurance availability. I strongly encourage those who have not yet secured their tickets to do so promptly, as this is an invaluable opportunity for learning and networking.

In addition to the convention, I am thrilled to announce a new initiative: a free online education series of webinars aimed at supporting all AICLA members, particularly those in remote and regional areas who may not always have the



opportunity to attend in-person events. The inaugural webinar in this series will focus on mental health and is scheduled to coincide with R U OK? Day on 12th of September. This day is part of a national suicide prevention campaign that encourages people to stay connected and have meaningful conversations that can make a difference. The statistics around suicide in Australia are sobering, with data showing that 8.6 people take their own lives each day, an estimated 65,000 Australians attempt suicide each year, and over 10 million Australian adults know someone who has died by suicide. I urge all members to participate in this important event, and as with all our educational offerings, attendees will be eligible to claim CPD points.

Speaking of Continuing Professional Development (CPD), I would like to remind all members of the requirement to accumulate 30 CPD points annually. The upcoming Claims Convention and our new webinar series offer timely opportunities to boost your CPD tally as we approach the end of the year.

As we move towards the close of the year, many divisions are busy finalising the remainder of their annual schedules and end-of-year celebrations. Alongside the national CC24 and webinar educational events, we have a number of division-specific events to look forward to: the WA division will be hosting a networking function and its annual Christmas lunch; SA/NT will be holding its annual luncheon; Queensland will host its annual charity race day and end-of-year luncheon; NSW/ACT will have its annual charity race day; and the Victorian division will hold its annual division awards night.

CONTINUING PROFESSIONAL DEVELOPMENT

All practising members of the institute are expected to comply with the requirements of continuing professional development.

To demonstrate compliance with continuing professional development, members must undertake an appropriate continuing education program.

Members are required to accumulate thirty (30) points over the year from 1 January to 31 December. One point equals one hour of qualifying professional activities.

The accumulation of points is on a self-assessment basis which is subject to random audits by AICLA.

There is no need to send through completed *CPD forms* to head office unless you are applying for an elevation or are asked (due to a random audit). Instead, we ask that you complete these annually and keep them saved locally.

Ron G Bennett

The funeral of AICLA life member Ron Bennett was held on Tuesday 13 August 2024 who passed away in late July 2024 at the age of 94



Ron Bennett, in his early life, worked for many years as a motor mechanic. He commenced his own Loss Adjusting practice, as RG Bennett & Co, in the late 60's, early 70's as a sole trader, principally handling motor vehicle assessments. He diversified soon after to the field of workers compensation enquiries and investigations, working closely with the State Government Insurance Office (SGIO) for many years. The business quickly expanded to employ 3-4 staff, managing claims for several Insurers, still mostly motor vehicle and workers compensation claims but also expanding into the area of fire and general claims.

Ron sold the business some 10 years later, the new entity became National (West) Loss Adjusters, which he worked for as an employee for a few years, opening and managing an office in Bunbury for them. During his adjusting career, Ron spent some time representing AICLA as a Committee Member, Vice President and also President. On retirement he moved to, and lived in Denmark WA for many years, then to Mandurah.

He was awarded life membership of AICLA and until recently always maintained an interest in the Institute, regularly attending the AICLA WA Christmas function. Ron was also a life member of WA Centre of Surf Life Saving and the Fremantle Surf Life Saving Club. He was also the longest serving Justice of the Peace in WA starting as a 29-year-old in 1959.
