#### **ELEVATIONS AND POST NOMINALS**

The criteria for the various classes of membership are set out in the Qualifications and Rights for Classes of Membership. If you meet the elevation criteria, please complete an *Application for Elevation* and ensure you complete a *CPD record sheet*. The password is aicla2018.

The following are guidelines for members regarding the use of AICLA post-nominals. Full details of the use of postnominals and the requirements for the different classes of membership are outlined in the *Qualifications and Rights for Classes of Membership*.

Affiliate: AICLA (Aff)
Associate: ACLA
Fellow: FCLA

Provisional members and Ordinary members (legacy membership class) are not eligible to use post-nominals but may state they are Provisional members of AICLA or Ordinary members of AICLA.

Associates and Fellows who maintain CPD accreditation are also eligible to use the term "Chartered Loss Adjuster". Details of CPD requirements are outlined in the *CPD Information Sheet*.

# CONTINUING PROFESSIONAL DEVELOPMENT

All practising members of the institute are expected to comply with the requirements of continuing professional development.

To demonstrate compliance with continuing professional development, members must undertake an appropriate continuing education program.

Members are required to accumulate thirty (30) points over the year from 1 January to 31 December. One point equals one hour of qualifying professional activities. The accumulation of points is on a self-assessment basis which is subject to random audits by AICLA.

There is no need to send through completed CPD forms to head office unless you are applying for an elevation or are asked (due to a random audit). Instead, we ask that you complete these annually and keep them saved locally.

- A completed CPD form showing 30 CPD points for the year
- Copies of relevant qualifications, including full academic transcripts (particularly for those applying for Associate level)

## CONTINUING PROFESSIONAL DEVELOPMENT (CPD)

All practising members are required to undertake continuing professional development and accumulate 30 CPD points annually (1 January – 31 December). One hour of qualifying activity equals one point.

CPD is self-assessed and may be subject to random audits. You do not need to submit *CPD forms* unless applying for elevation or requested during an audit. We recommend completing your CPD form each year and saving a copy locally for your records.

Staying current with your details and CPD helps you get the most out of your AICLA membership and supports the professional standards of our industry.
