FROM THE INSTITUTE PRESIDENT DARRELL STOPS

Dear Members,

Welcome to the last LA News of 2025. There has been considerable weather activity in the past few weeks, but it could have been worse if Tropical Cyclone Fina had crossed the coast over Darwin rather than passing close by. We appreciate there was severe damage in the Tiwi Islands, a number of remote communities affected and even parts of Darwin impacted, but it could have been significantly worse, with TC Fina being the highest category tropical cyclone in the region since Tropical Cyclone Tracy devastated Darwin at Christmas in 1974.

The International Division was particularly hit hard during November, with two countries, Vietnam and the Philippines, being hit by two typhoons in the past few weeks. In Vietnam, there have been over 60 deaths and a number of people still missing from the typhoons. There is suggestion of nearly 200,000 homes being affected and the total damage bill in the order of hundreds of millions of dollars. The worst affected areas were in south and south-central Vietnam: Quang Ngai, Gia Lai, Dak Lak, Khanh Hoa, Lam Dong and Hoi An, which is a beautiful heritage port and a popular tourist town. Most of the Vietnamese adjusters from Ho Chi Minh City and Hanoi, the capital city, are very busy in these areas at present, among them AICLA members. Significant flooding is continuing after the two typhoons due to heavy, persistent rain, with more deaths, people missing, and crops, livestock, villages, homes, businesses and infrastructure all severely affected. Our thoughts are with all people affected and our colleagues endeavouring to assist people and make a difference to outcomes.

In the Philippines, the country was impacted by Typhoon Fung-Wong (known locally as Uwan) on 9 November 2025, which also made landfall over Taiwan. This typhoon struck just five days after Typhoon Kalmaegi (known locally as Typhoon Tino, one of the two recent typhoons to affect Vietnam), causing at least 33 deaths and over 50 serious injuries, with one death and 95 serious injuries in Taiwan. There was significant damage to houses, commercial structures and infrastructure in the Bicol Region, Cebu and Northern Luzon in the Philippines. Adding insult to injury,

two earthquakes also hit the Philippines in the Cebu region on 30 September 2025 at 6.9 Richter scale, and the Davao Doublet EQ at 7.4 Richter scale and 6.8 Richter scale on 10 October 2025, hitting the Mindanao region.

On communicating with International Director Budi Maharesi, he advises local Divisions are busy but coping well with the number and type of claims, providing invaluable assistance to both policyholders and insurers.

On 23 October 2025, the Southland Region of New Zealand (for the uninitiated, think bottom of the South Island near Invercargill) was subject to winds of up to 230 km per hour, causing power outages and damage to homes, businesses and infrastructure, and unfortunately one fatality from a fallen tree. Insurers have estimated close to 10,000 claims being lodged at the time of this publication. At least one loss adjusting company mobilised adjusters from Australia, including one from Perth, to assist in the handling of claims. The NZ Division Chair, Trina Far, advises the feedback on loss adjusters being involved and making a difference with the handling of the claims is positive some 4–5 weeks since the event.

The event and associated claims will be sure to be a topic discussed at breakfasts planned by the Division to be held in Wellington, Auckland, Christchurch and Tauranga prior to Christmas. The breakfasts are free to members and will be a further continuation of the efforts and work being put in by the NZ Division, led by Trina.

There are a number of other activities in December to round off a very successful year, the first being the NSW/ACT

Division Charity Race Day at Royal Randwick on Friday, 5 December 2025. All proceeds from the day go to Tribal Warrior, a charity helping kids and families. It is a great day and a very worthwhile cause. On the same day, the WA Division is holding its annual Christmas Lunch at Anzac House in St Georges Terrace, Perth. The event is sold out for a second year, with only members and sponsors and their guests attending the traditional three-course Christmas fare, with the keynote speaker this year being Steven Bradbury, Olympic Gold medallist of "last man standing" fame.

The last event is the Vic Awards Night at the Crown Palladium in Melbourne. This is the 10th year of the event, which has grown each year and is now a genuine standout on the insurance calendar nationally as an event not to be missed. On speaking with Division Chair Nish Chandra, he advises "the Crown Palladium is quickly filling up, and the Organising Committee is very pleased with how the event is coming together for what should be another memorable night with pretty much everyone that we deal with on insurance claims in the room". I, for one, am very much looking forward to the night, being my first time at the event.

I would like to take the opportunity to congratulate Carl Coldham on becoming Division Chair in WA following a recent committee meeting. Carl advises becoming Division Chair is an enormous privilege and honour, and his focus will be continuing to promote AICLA in WA through professional development, networking and events such as the educational breakfast seminars and lunches. Dave Bazen, Managing Director of Asta Group, is very supportive of Carl becoming Division Chair and reiterates it is a wonderful opportunity for him in every sense. Dave Bazen has been a wonderful supporter of AICLA over a long time, with Asta Group

having 13 members in WA, the highest of any firm in WA.

Looking ahead to 2026, AICLA's premier international convention, the Asia-Pacific Claims Convention (ACC), will be held on 12–14 May at Four Points by Sheraton Hotel, Patong Beach. Following on from the record-setting event in Osaka, we look forward to another standout occasion in the stunning location of Thailand. Keep an eye out for the initial registration brochure, due for release in mid-December.

Finally, before wishing everyone a safe and relaxing Christmas with family and friends, and a happy, healthy and prosperous 2026, there is a good news story out of WA. We had concerns about the welfare of retired life member Eric Kitchen. Eric is the last of four retired life members in WA, with the other three, Alan Smyth, Charlie Pryde and Ron Bennett having passed. After trying to contact Eric on the last mobile number, email and then speaking to more senior members who had not heard from him, enquiry was made at his last known residential address. He wasn't there, but we managed, through the property manager, to speak to a real estate company who provided Eric's daughter's details. She, in turn, gave details to Eric, who contacted me. He is well, having recently moved into care, and for his 91 years of age (he volunteered the age) is very sharp and finishing writing a book on his time in Australia since emigrating from the UK. We arranged to catch up in the new year, and I will provide a further update on this occurring.

CONTINUING PROFESSIONAL DEVELOPMENT (CPD)

All practising members are required to undertake continuing professional development and accumulate 30 CPD points annually (1 January – 31 December). One hour of qualifying activity equals one point.

CPD is self-assessed and may be subject to random audits. You do not need to submit *CPD forms* unless applying for elevation or requested during an audit. We recommend completing your CPD form each year and saving a copy locally for your records.

Reflections on a Career in Loss Adjusting

EARLY BEGINNINGS

Leaving high school at the end of Form 4 (Year 10) was an unexpected turn for me when I began my secondary education in 1959. Family circumstances meant I needed to start work at the end of 1961, and I found myself as a young, pimple-faced lad with a Beatle haircut stepping into Royal Insurance at 414 Collins Street, Melbourne. There. I was fortunate to be introduced to the worlds of workers compensation and property claims. Despite the claims manager being a tough taskmaster, he proved to be an excellent mentor. During nearly four years under his guidance, I learnt a crucial lesson that has stayed with me throughout my 60-year career as a Loss Adjuster: "never be afraid to ask the tough question".

ONGOING EDUCATION AND PROFESSIONAL GROWTH

Even though I finished secondary school at the age of almost 16, I continued my education by qualifying as an Associate of the Australian Insurance Institute and the Loss Assessors Institute of Victoria through examinations. Later, I completed my higher school certificate and went on to graduate from Melbourne University with a Bachelor of Commerce.

BECOMING A LOSS ASSESSOR

I left Royal Insurance in 1965, drawn into the career of a "Loss Assessor", as we were called until the mid-1970s. My mentor during my early years in adjusting was Phil Symons, and I was his first trainee. Looking back on the eight years I spent with Mr Symons, always addressed formally, I remain deeply grateful for the time and effort he invested in me.

BUILDING A CAREER AND EARLY CASES

In 1976, after three years in partnership with Brian Mills, we joined others to form McLaren Dick and Company, operating under licence to McLarens in London. While people often ask about my first case, which was a rather uneventful forced entry and theft at the Deer Park Hotel, I usually share the story of a more interesting case involving a fire in a rag trade warehouse in Flinders Lane, Melbourne. At that time, Flinders Lane was the centre of the rag and fashion trades.

The case appeared to be arson to me, but it was later confirmed to be non-suspicious by a seasoned Fire Origin and Cause Investigator. What I believed to be a second seat of fire turned out to be a flashover within the confined space, fuelled by synthetic materials. This experience taught me another important lesson.

THE IMPORTANCE OF ASKING TOUGH QUESTIONS

Reflecting on the advice to "ask the tough question", I often tell young adjusters I mentor that, when circumstances hint at suspicious activity, such as a fire with multiple points of origin, they should ask the Insured pointed questions like, "Where were you at the time of the blaze?" and, if necessary, "Were you or someone directed by you involved in setting this fire?" I also caution them to be ready for strong reactions to the latter question.

Responses to this question have ranged from anger to indignation. On at least two occasions, the answer was, "That is for me to know and you to find out," or similar. In one instance, arson by the Insured was proven and the claim denied. In another, the Insured successfully defended against a criminal charge due to mishandling and mislabelling of evidence by the VicPol Forensic Chemist—a mistake I witnessed but was fortunate not to be crossexamined about.

Years later, I received a phone call from Detective X, whom I know well, informing me that the Insured had confessed on his death bed to his son that he had set the fire for financial gain. Detective X and I felt vindicated by this confession, and presumably the Insured found peace in clearing his conscience. The key lesson for the Forensic Chemist in this case was the need to handle evidence with care to avoid contamination and to maintain continuity. This is a lesson we should all remember.

CAREER HIGHLIGHTS AND REFLECTIONS

My career has taken me to Hong Kong, the Pacific Islands, New Zealand, and across all States and Territories of Australia, working on catastrophe events, fires, explosions, and more. Throughout, I've had the privilege of meeting all sorts of people. I can honestly say I have cherished every moment of helping others in times of disaster and trauma, and I am grateful for the chance to make a difference.

CHANGES IN THE PROFESSION AND MOTIVATION

What has changed in the profession, and what keeps me motivated? The answer to the second question is simple and less controversial: I am motivated by the daily variety of cases, the constant learning, and the people I have worked with, both colleagues and instructing principals.

In terms of changes, in my early years there was pressure to provide service and minimise claim duration, but we were not bound by Service Level Agreements (SLAs) and Key Performance Indicators (KPIs) that today often impose unrealistic timelines, especially for major and complex claims. In the 1980s and 1990s, claims were settled efficiently and to the satisfaction of all parties, without the burden of meeting frequent deadlines for reports that add little value to the process.

FINAL THOUGHTS

My final tough question: have SLAs and KPIs truly made a difference to consumers' perceptions of how insurers process their losses?
