

When I commenced my role as president in October 2020, one of the goals I set was to increase membership to the magical figure of 1,000. I am delighted that current membership of AICLA now stands at 1120. There was a record number of new members joining in June, 33 in one month, and a further 16 in July. This growth has been due to a combination of a significant marketing campaign in conjunction with the hard work, educational activities and networking events conducted by divisions. The ongoing contribution from divisions ensures members and supporters alike benefit from Institute activities, hence the rapid increase growth in membership over the past three years.

The Berjaya Hotel in Kuala Lumpur, Malaysia, has been selected as the venue for ACC24 on the 8 – 10th of May 2024. Again, following on from the incredible success of ACC23 in Bangkok the organising committee for ACC24 has been formed and in anticipation of their hard work, my thanks go out to (A. Khoo, D. Tran, P. Kaewdeangtien, B. Maharesi, N. Ackers T. Libke and T. Thangamany).

The board meeting and AGM are planned for Brisbane on 26/27 October where my tenure as president will come to an end. The board meetings generate healthy debate with the objective of improving outcomes for members.

Tony Libke CEO, Adrian Libke CEO elect, and I will be reviewing all AICLA policies to ensure that we have a sustainable association moving forward for the coming years.

The Carey Bird Scholarship scenario which this year has been written by Bill Clarke, Executive adjuster, Charles Taylor Brisbane, will be issued next week. The Carey Bird Scholarship is a claims scenario in which the applicants are to submit a report and show their knowledge and expertise on the topic, a Building Construction Dispute. The Scholarship commenced in 2013 and is in recognition of Carey who tragically lost his life while working in Christchurch during the earthquakes in 2011. This scholarship honours the great work, dedication and passion displayed by loss adjusters, I encourage all to take part as there is an excellent prize for this prestigious award:

- Attendance at the Claims Convention (Sydney) plus airfares (economy), accommodation, meals and out of pocket expenses associated with attendance at the convention; or
- Attendance at the Asian Claims Convention, plus airfares (economy), accommodation, meals and out of pocket expenses associated with attendance at the convention, or
- a cash payment of AUD\$3,000.

Finally, the lifetime achievement award is now open, and we look forward to receiving applications for those deemed worthy to have this title bestowed upon them. Inaugural winners for 2023 were Tony Morgan and Chan Hwee Seng. We look forward to the board deciding on the next winner using the following criteria:

- To be awarded to an AICLA member who has over an extended period (minimum of 25 years) demonstrated a commitment to the promotion of the profession of loss adjusting through personal achievement, and the education, training, mentoring and overall personal development of other loss adjusters.
- Eligible to be nominated by anyone involved in the profession of loss adjusting, Division Council or AICLA Board.
- Submissions to be in writing outlining how the candidate achieved the criteria.
- Maximum of one award each year.
- Award may be granted to a member who has retired.
- Current or recent (past two years) Board members of AICLA are not eligible.


