

In what will undoubtedly be the first of an ongoing series of Members-only collaborative technical session was held on 23 August 2023. AICLA adjusters attended the Scoresby premises of forensic engineers and diary advertisers, @ATTAR, to see first-hand how failure analysis and forensic testing of structures, vessels and materials supports the work undertaken by loss adjusters. The morning started with a hearty breakfast and was followed by a tour of ATTAR's laboratories and an interactive introduction to Materials and Flooring Failures made userfriendly by drawing on case studies. Members were treated to live demonstrations including Fractography, using a Stereo Microscope and Scanning Electron Microscope. An optical microscope was also used to demonstrate microstructural analysis. In the non-destructive-testing (NDT) space demonstrations of Digital Radiography, Phased Array ultrasonic and Magnetic Particle testing was undertaken.
