# FROM THE INSTITUTE CEO, TONY LIBKE

Dear Member,

I would like to thank the President, and my good friend, Glyn Lloyd for inviting me to pen this edition of LA News as I will be stepping down as Chief Executive of AICLA during the board meeting at the end of October. I am not retiring but will be taking a less active role while pursuing other personal and business interests. I have agreed with the Board to continue to be part of the organising committees for the Asian Claims Conventions in 2024 and 2025.

Recently I had the opportunity to have lunch with Mike Brooke who was visiting Brisbane from New Zealand. Some of you will know the name and while Mike has been retired from loss adjusting for many years, he remains active and is on a number of boards. Mike was the catalyst for the establishment of AICLA. He was the President of the Institute of Loss Adjusters New Zealand (ILANZ) and approached the Australian Institute of Loss Adjusters (AILA) of which I was the Administrative Officer regarding the two bodies joining. Discussions around this time also commenced with the Chartered Institute of Loss Adjusters Australasia (CILA) on a possible merger with AILA. The three bodies in merger negotiations were each represented by powerful and persuasive people, Mike from ILANZ, Leo Fluitsma (AILA) and Tony Morgan (CILA). Those men were able to gain the support of their respective boards, and ultimately their membership, to form AICLA. They are the architects of the Institute we have today, something they and others involved in the process can be very proud.

Following the formation of AICLA in 1997, Bob Richards the highly respected CILA member was selected President and I was appointed Secretary and administrator. At this time there was also an important group of loss adjusters from AILA and CILA working with the Australian Insurance Institute (now ANZIIF) to develop the first Diploma level course for loss adjusters which resulted in establishment of the highly regarded Diploma of Business (Loss Adjusting). Both the Diploma course and Institute have continued to develop and advance in the years since.

#### **ELEVATIONS AND POST NOMINALS**

The criteria for the various classes of membership are set out in the *Qualifications and Rights for Classes of Membership*. If you meet the elevation criteria, please complete an *Application for Elevation* and ensure you complete a *CPD record sheet*. The password is aicla2018.

The following are guidelines for members regarding the use of AICLA post-nominals. Full details of the use of post-nominals and the requirements for the different classes of membership are outlined in the *Qualifications and Rights for Classes of Membership*.

Affiliate: AICLA (Aff) Associate: ACLA Fellow: FCLA

Provisional members and Ordinary members (legacy membership class) are not eligible to use post-nominals but may state they are Provisional members of AICLA or Ordinary members of AICLA.

Associates and Fellows who maintain CPD accreditation are also eligible to use the term "Chartered Loss Adjuster". Details of CPD requirements are outlined in the *CPD Information Sheet*.

Following the completion of the AGM drinks and canapes were held, enabling attendees to catch up with industry colleagues and welcome in the new Council.






#### **QUEENSLAND**


